



Prof. Liu Mingkang
Former Chairman, China Banking Regulatory Commission;
BCT Distinguished Research Fellow, Institute of Global Economics and Finance
The Chinese University of Hong Kong

Prof. Liu Mingkang is a member of the 17th Central Committee of the Communist Party of China and a member of the China National Energy Commission. He served as the first Chairman of the China Banking Regulatory Commission (CBRC) between March 2003 and October 2011. He also served as a member of the Monetary Policy Committee of the People's Bank of China.

Before heading the CBRC, Prof. Liu held various positions in both banking institutions and government agencies, including, among others, Chairman and President of Bank of China, Chairman of China Everbright Group, Deputy Governor of the People's Bank of China, Deputy Governor of the China Development Bank of China, Deputy Governor of Fujian province and Secretary-General of the Fujian provincial government.

Prof. Liu also serves as a senior fellow of the Hong Kong Institute of Bankers. He was a member of the Financial Stability Board (FSB), Vice Chairman of the Standing Committee on Supervisory and Regulatory Cooperation under the FSB, a member of the Governance Body of the Basel Committee on Banking Supervision (BCBS), and a director of the Board of International Center for Leadership in Finance (ICLIF), Bank Negara Malaysia and Vice Chairman of the International Institute of Finance. He also served as a member of the Advisory Council of the Daimler-Chrysler Group.

Prof. Liu sits on the International Advisory Boards of both Guanghai Management School of Peking University and the School of Economics and Management of Tsinghua University. He is the Honorary Dean of the Lingnan (University) College of Sun Yat-Sen University, BCT Distinguished Research Fellow of the Institute of Global Economics and Finance at the Chinese University of Hong Kong, and Honorary Professor of the CUHK Business School.

劉明康教授是第十七屆中共中央委員會委員及國家能源委員會委員，於 2003 年 3 月至 2011 年 10 月期間擔任中國銀行業監督管理委員會（中國銀監會）首任主席，也曾任中國人民銀行貨幣政策委員會委員。

在領導中國銀監會前，劉教授歷任多間銀行及政府機構要職，包括中國銀行董事長兼行長、中國光大集團董事長、中國人民銀行副行長、中國國家開發銀行副行長、福建省副省長兼省政府秘書長等。

劉教授現為香港銀行學會資深會士，他亦曾任金融穩定理事會成員及該會下設的監管合作常設委員會副主席、巴塞爾銀行監管委員會決策委員會成員、馬來西亞中央銀行下屬金融領導力國際中心董事會董事、國際金融協會副主席，以及 Daimler-Chrysler Group 國際諮詢委員會委員。

目前，劉教授擔任北京大學光華管理學院國際諮詢委員會委員、清華大學經管學院國際諮詢委員會委員、中山大學嶺南學院名譽院長、香港中文大學全球經濟及金融研究所 BCT 銀聯集團傑出研究員，以及香港中文大學商學院榮譽教授。
